Principal's Message

Welcome to 2018!

We are continuing to celebrate our "10 Year Celebration of Excellence" here at Hidden Hollow Elementary! We are also continuing to "Go for the Gold" every day. We are also continuing with our S.T.E.A.M. challenges throughout the school and in our classrooms. Thank you to everyone who is supporting our efforts this year.

Last month we had the character trait of caring. As I communicated with teachers, students, and parents in the community, it was amazing to see the efforts being made by so many to care about those in need. Thank you so much for all the caring that occurred, especially during the holiday season.

As we begin a new year, we would like to start with a "Kindness Challenge." At the beginning of the year, a parent suggested this to me. I thought it would be great to start out the New Year with this challenge.

Our challenge to you is this...

We are asking everyone in our school community - teachers, principals, staff members and students - to each perform 5 acts of kindness daily for 3 weeks. We would like you to report each week (to your child's teacher – a form will be provided each week) the results (from your family, etc.). As a staff, we will also be tracking our success. Just as a staff, if we complete this challenge, we will perform 7,350 acts of kindness. If we add each child, it will add up to nearly 96,000 acts if kindness.

It may be as simple as opening the door for someone in need, or carrying something inside for someone. It might also include cleaning up a room in the house, or helping make a meal at home. You choose, but we would LOVE to have everyone involved.

We would like to begin our challenge on the 8th of January and continue through the 28th of this month. We will report out on Monday, January 29th with the total amount of acts of kindness, which have occurred in our school community.



Utah Resident Income Tax Credit. Individual Utah taxpayers can claim a 5 percent Utah state income tax credit on UESP account contributions up to a certain amount for each account beneficiary who was younger than age 19 when designated as such on an account. If the beneficiary age requirement is met, you can claim the tax credit every year that you contribute for the life of the account.

Not Just for Utah Colleges

When your child is ready for college, you can use your money at any university, college, or technical school—in Utah or out of state—that participates in federal financial aid programs.

- 1 Read the Program Description and open an account for free online at uesp.org or by submitting an Individual Account Agreement (form 100).
- 2 Name a beneficiary and choose an investment option based on your financial goals and how long you have
- Start with a zero balance or make a first-time contribution to qualify for a free back-to-school kit—then invest what you want, when you want.

Free Back-to-School Kit

When you open a UESP account online and contribute \$10, your child is eligible to receive a free back-to-school kit that includes two pencils, a pencil sharpener, an eraser, a 6-inch ruler, and a pencil case. Please allow four to six weeks for delivery.

Quantities are limited and UESP reserves the right to discontinue the offer at any time. To receive your back-to-school kit:

- Visit uesp.org and open a new account using the promotional code BTS2017.
- The account owner and beneficiary must both be Utah residents and new to UESP.
- The beneficiary must be the child of the account owner.
- The account must be opened on or before November 2, 2017, with a \$10 contribution.
