- K-2: We will use the DRA and other common assessments to measure student progress in reading.
- 3-6: We will use the Spring 2014 LA SAGE as a baseline comparison to the Spring 2015 LA SAGE test to measure our students' progress in reading. We will also use the DRA and grade level common assessments to monitor progress towards our goal.

## List the specific steps of the ACTION PLAN to reach this goal.

- 1 Professional development will be key to helping our teachers meet this reading goal for the school. We plan to have our teachers attend one summer training day to work on team building and plan strategic reading interventions. (\$5000)
- 2 We will increase our small group aide time by hiring paraprofessional educators to assist the teacher in working with students. (\$6000)
- 3 Obtaining high interest reading materials will be key to reaching our reading goal; therefore we will purchase scholastic news for each classroom and add additional nonfiction literature (integrated with our science themes) for our guided reading library. (\$4800)
- 4 We will continue to maintain and build our STAR reading program by hiring a program coordinator through matching AmeriCorps grant

funds. (\$5000)

- 5 Through assessment and teacher recommendation, students will be identified to participate in a double dose reading program. We will hire aides to work with these students in strengthening their vocabulary, fluency and comprehension. (\$6600).
- 6 We will purchase iPad minis to use in our classrooms for formative and summative assessments, as well as apps used to reinforce concepts in reading and math (\$1148.55)
- 7 We will purchase Science materials and supplies, as well as software and online subscriptions to further integrate reading and math in Science, specialties, and core. (\$5700)
